Policy changes will be communicated as soon as possible. If there are individual concerns related to your child wearing a mask, please speak to the instructor privately.
- Parents of children 5 and over will not be allowed in the building / waiting rooms in order to limit gathering sizes. Parents of children under 5 may remain in the waiting rooms, following the current mask policy. We ask that you keep siblings home if at all possible. If there are individual concerns related to staying in the building, please speak to the instructor privately.
- You agree to not drop your child off more than 5 minutes before scheduled class time. This is to help with social distancing, and to make sure children are not left unattended.
- You acknowledge the contagious nature of Covid-19.

*2021/22 Dance year runs Sept 13, 2021 – mid-May 2022

*First installment is due at registration to hold your spot and is non-refundable (unless season does not go forward). Only check or cash will be accepted.

*Second installment will be due the week of 9/13/21. Check, cash or credit card will be accepted.

*Tuition fees (installments 3-10, Oct-May) are due the 1st of each month. A \$10 late fee will be applied to accounts not paid by the 8th. If no payment is received by the end of the month, your child will not be allowed to attend class until paid. After 2 late payments, the entire balance must be paid in full OR must enroll in auto pay.

*Tuition may be paid in cash, check (payable to Revolution Dance Center) or credit card. We offer an autopay plan (Oct-May) to make it easier for you to make timely payments. A \$3 processing fee will be added to all credit card transactions.

*In the event of a returned check, a \$25 fee will be charged to the account.

*Tuition remains the same regardless of absences and length/number of weeks per month.

*Full tuition payments will not be accepted this year. Everyone will be on a month-to-month basis.

*An all-inclusive recital fee will be added to all accounts and must be paid by February 15th (see recital fee explanation for more information).

*Revolution Dance Center must receive notification in writing prior to the next billing date in order to withdraw from classes. No refunds will be given if notification is not received on time.
